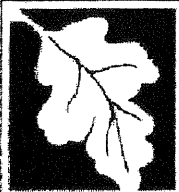

MASSACHUSETTS REGULATIONS THAT REQUIRE THIS NOTICE

This notice is being provided pursuant to the Massachusetts Contingency Plan and the notification requirement at 310 CMR 40.1406. The Massachusetts Contingency Plan is a state regulation that specifies requirements for parties who are taking actions to address releases of chemicals (oil or hazardous material) to the environment.

THE PERSON(S) PROVIDING THIS NOTICE

This notice has been sent to you by the party(ies) who is/are addressing a release of oil or hazardous material to the environment at the location listed in **Section A** on the reverse side of this form.

PURPOSE OF THIS NOTICE

Parties who are taking actions to respond to releases of oil or hazardous material to the environment are required by state regulations (referred to above) to notify the owners of property where the oil or hazardous material is or is likely to be present. These same parties are also required to notify property owners upon completion of actions to address the oil or hazardous material, or if additional investigations show that the oil or hazardous material is not, as previously suspected, present at a property. **Section C** on the reverse side of this form indicates the circumstance under which you are receiving this notice at this time.

EXECUTIVE SUMMARY

We are sending you this notice because property records show you may own waterfront property on Buzzards Bay that may be part of the on-going assessment and cleanup of oil that was spilled by the Bouchard Barge B120 in April 2003. Richard J. Wozmak, P.E., P.H. of EnviroSense, Inc. is the Licensed Site Professional (LSP) overseeing assessment and cleanup activities under Massachusetts law to make sure that the oil is cleaned up. Through the assessment process we are required to demonstrate that the affected shoreline meets the Massachusetts Department of Environmental Protection cleanup standards.

In case you were unavailable to attend our public meetings or review assessment and cleanup reports on the www.buzzardsbay.org website, we are letting you know that we are in the last stages of the cleanup and assessment process. In this notice we tell you about documents that are available to show what we have done and what remains to be done. The assessment process and Massachusetts environmental regulations are very complicated and technical. If you have questions, please contact our technical team. You are not required to do anything, but your input is welcome, and if you see any oil that you think may be left over from the spill please contact the technical team at (800) 731-5430.

INTRODUCTION

This package of information serves as notification to owners of properties that may be within the boundaries of the area affected by the release of No. 6 fuel oil from Bouchard Barge B120 that occurred on April 27, 2003 in Buzzards Bay (the "Site") and currently regulated under the Massachusetts Contingency Plan (MCP, the State's environmental regulations). This notification is for the transmittal of a Phase II Comprehensive Site Assessment Report (Phase II Report) and/or a Response Action Outcome (RAO) Statement to the Massachusetts Department of Environmental Protection (MADEP) on August 3, 2006 in general accordance with the MCP. The Phase II Report describes the status of the Site cleanup and evaluates potential human and environmental risks, if any, associated with residual oil. The RAO Statement is the regulatory document that completes and concludes assessment and cleanup activities at the Site based upon the findings and conclusions of the Phase II Report. The Phase II Report and RAO Statement are available for review at the MADEP office in Lakeville, Massachusetts and can also be found online at the www.buzzardsbay.org website. This notification package also includes a MADEP "Informational Notice to Property Owners" form and map showing the shoreline segment (that was affected by the release) that may include your property.

BACKGROUND AND RESPONSE ACTION HISTORY

On or about April 27, 2003, an unknown volume of No. 6 fuel oil, estimated to range between 22,000 gallons and 98,000 gallons, was released from Bouchard Barge B120 after entering the western approach of Buzzards Bay, Massachusetts. Winds and currents drove released oil to the north, northwest, and northeast in the days following the spill until it became stranded on the shoreline. The municipalities where released oil impacted the shoreline included: Westport, Dartmouth, New Bedford, Fairhaven, Gosnold, Mattapoisett, Marion, Wareham, Bourne, and Falmouth. The dispersion of oil by wind and current resulted in approximately 84 miles of impacted shoreline with varying degrees of shoreline oiling, ranging from trace amounts to relatively heavy. Shoreline oiling was generally concentrated at exposed points and peninsulas on the northern shore of Buzzards Bay. In addition, a few isolated areas of sporadic shoreline oiling were reported in parts of Rhode Island and the Elizabeth Islands.

Emergency cleanup actions were immediately initiated and were conducted through September 3, 2003 by Unified Command (consisting of the U.S. Coast Guard, MADEP, and the responsible party) in accordance with the Federal Oil Pollution Act (OPA) of 1990. These cleanup actions consisted of deployment of containment boom around the barge's stern and oil recovery from the water surface, power washing of solid surfaces, manual removal of oil and oiled debris using various manual techniques, and sediment excavation and replacement at limited areas of the shoreline. Emergency restoration, including replanting of salt marsh vegetation, was also conducted during this time frame. These initial cleanup actions removed the vast majority of the oil, both floating on the water surface and stranded ashore.

In September 2003, oversight of assessment and cleanup activities transitioned from Unified Command to a Licensed Site Professional (LSP) certified by the Commonwealth of Massachusetts to oversee assessment and cleanup of releases of oil and/or hazardous materials in accordance with the MCP. On September 15, 2005, an Immediate Response Action (IRA) Plan was transmitted to MADEP that outlined steps to perform further cleanup in limited areas of the shoreline, to respond to citizen's complaints of oil along the shoreline, to assess the potential presence of buried oil, and to investigate the segments that did not meet Unified Command's endpoint cleanup criteria or were not inspected by Unified Command. IRA cleanup and assessment activities have been ongoing, and are summarized in multiple status reports transmitted to MADEP.

In May of 2004, a Phase I Initial Site Investigation Report (Phase I Report), Conceptual Site Model (CSM) and Tier Classification was transmitted to MADEP. The Phase I Report primarily summarized initial investigation activities on the extent and magnitude of oil impacts to the shoreline and subtidal zone of Buzzards Bay. The CSM provided an understanding of the distribution, characteristics, and fate of oil in Buzzards Bay, following the release. The Tier Classification was based upon the Phase I Report, and using the MADEP's numerical ranking score sheet, the Site was classified as Tier 1A.

Also, in May 2004, a Partial Class A-2 RAO Statement was filed for 57 of 120 shoreline segments that were impacted by the release. The RAO Statement was based upon information presented in the Phase I Report and concluded that there was "No Significant Risk" of harm to human health, safety, public welfare and the environment as defined in the MCP, and further assessment or cleanup actions under the MCP were not necessary at these shoreline segments.

A Phase II Scope of Work and updated CSM was transmitted to MADEP for its approval in August 2005 to address the remaining 63 shoreline segments and subtidal area. The updated CSM was developed to include new information collected at the Site since the Phase I Report and to address MADEP comments. Based upon the updated CSM, the Phase II Scope of Work outlined environmental assessment activities to comprehensively evaluate the extent, magnitude, and potential risk associated with oil and oil compounds that may have been present at the remaining 63 shoreline segments and the subtidal area underlying Buzzards Bay. Phase II activities were initiated in the fall of 2005 and continued through the spring of 2006. A Phase II Report that documents, evaluates, and discusses the findings and conclusions of the environmental assessment is being transmitted to the MADEP on August 3, 2006. A copy of the Phase II Report conclusions is attached to this notification package.

Based upon the Phase II findings, many of the remaining segments do not contain residual oil from the release. For the other segments, minor, sporadic occurrences of oil may be present along the shoreline or in the subtidal area under Buzzards Bay, and the relatively minor oil that is present is primarily located along the shoreline as weathered, hardened, tar-like splatter on boulders and riprap (ranging from 0.5 inch up to four inches in diameter), which typically does

not come off to the touch unless vigorously disturbed. The exceptions to this condition are the peninsula at the Hoppy's Landing that is part of the Long Island And Causeway South segment in Fairhaven and Leisure Shores that is part of the Brandt Island West segment in Mattapoisett. At the peninsula of Hoppy's Landing, most of the remaining oil is present as small (generally less than 2 inches in diameter) areas of hardened pavement (typically on marsh sediment), but small amounts of tacky oil are observed in sheltered locations beneath rock surfaces, where exposure to tidal action is limited. At Leisure Shores, small particles of oil (colloquially identified as "flecks") that are typically less than 0.5 centimeters (cm) in diameter are dispersed in the sand along a portion of the beach.

Based upon the Phase II Report findings and conclusions, a Partial RAO Statement is also being transmitted to MADEP on August 3, 2006 for 61 of the 63 shoreline segments and the subtidal area underlying Buzzards Bay. A copy of the RAO Statement summary is also attached to this notification. The RAO Statement concludes that there is "No Significant Risk" of harm to human health, safety, public welfare and the environment as defined in the MCP, and further assessment or cleanup actions under the MCP are not necessary at these 61 shoreline segments.

The remaining two areas that require further assessment and/or cleanup under the MCP include the Leisure Shores area of the Brandt Island West segment in Mattapoisett and the peninsula of Hoppy's Landing within the Long Island And Causeway South segment in Fairhaven. The feasibility of performing further cleanup of these two segments is presented in a Phase III Remedial Action Plan that is also being transmitted to MADEP on August 3, 2006. Once these two remaining areas reach an endpoint acceptable to the MADEP, Partial RAO Statements will be transmitted to MADEP concluding "No Significant Risk" and that further assessment and cleanup actions are not warranted under the MCP.

CLOSING

The findings, conclusions, and recommendations of the reports discussed above along with other documents describing assessment and cleanup activities for the Site have been presented and discussed at numerous public meetings held at the Whaling Museum in New Bedford. In addition, these reports are available for review at the MADEP offices in Lakeville, and can be viewed online at the www.buzzardsbay.org website. Future reports required by the MCP will also be transmitted to the MADEP and posted on this website for public viewing and review.

PHASE II COMPREHENSIVE SITE ASSESSMENT CONCLUSIONS

As stated in the introduction, the primary objectives of the Report were to:

1. Characterize the magnitude and extent of residual oil using sufficient laboratory analytical data and qualitative surveys; and
2. Evaluate if a condition of No Significant Risk (NSR) to human health, public welfare, safety, and the environment is present at each of the remaining 63 segments and the subtidal zone.

As discussed in detail in Section 7.0 - Phase II Assessment Activities, weathered residual oil is predominantly absent from the majority of the 63 intertidal shoreline segments and the subtidal zone. Where residual oiling has been observed in the most recent surveys, its presence is limited to either haphazard, discontinuous, hardened rock splatter, small sand-sized oil particles, or sand-encrusted tarballs, tarmats or pavement found in discrete and oftentimes sheltered locations. If encountered by a field team or reported by the public, this residual oil was typically either removed or remediated (e.g., rototilling). More than 160 sediment samples representing the current worst-case conditions were collected and analyzed for EPH fractions and PAH. EPH fractions were rarely detected in sediment (7 out of 161 samples or a frequency of less than 5 percent). PAH were detected in more than half the sediment samples, as would be expected because PAH are derived from both combustion ("pyrogenic") and petroleum ("petrogenic") sources. Forensic evaluation was conducted to evaluate the source of PAH for a few samples where elevated PAH (compared to other samples) were detected, and most were found to be unrelated to the B120 oil. Those samples that were determined to be related to the B120 oil, as well as those samples with detected PAH compounds that were not forensically evaluated, were assumed to be related to the release of B120 oil, and evaluated as such in the Method 3 Risk Characterization.

The Method 3 Risk Characterization (Appendix D) evaluated potential risks associated with identified constituents of concern to human health, safety, public welfare, and the environment in accordance with the MCP (310 CMR 40.0090), MADEP Technical Updates (2002 a-e; 2006) and MADEP Guidance (1995; 1996). This assessment concluded that a condition of No Significant Risk to human health and safety exists at the Site. A condition of No Significant Risk to public welfare exists at 61 of the remaining 63 segments, and a condition of No Significant Risk to the environment exists at 62 of the 63 remaining segments and in the subtidal zone. A condition of No Significant Risk to public welfare has not been demonstrated at this time for two localized areas where residual oiling has been characterized as a potential nuisance condition (and therefore different from residual oil in other areas) at a portion of the Leisure Shores area at segment W1F-02 and the southern tip of Hoppy's Landing in segment W2A-10. A condition of No Significant Risk to the environment was not concluded at this time for the



southern tip of Hoppy's Landing due to the presence of pavement amongst the cobble and tarballs on marsh sediment.

Based on the conclusions above, additional response actions will be conducted at a portion of the Leisure Shores location at segment W1F-02 and the southern portion of Hoppy's Landing at segment W2A-10. These additional response actions will be described in a separate Phase III Remedial Action Plan. For the remaining 61 of 63 segments and the subtidal zone where a condition of No Significant Risk to human health, public welfare, safety, and the environment was demonstrated in the Method 3 Risk Characterization, response actions are complete and a Partial Class A-2 Response Action Outcome statement for these locations will be submitted under separate cover.

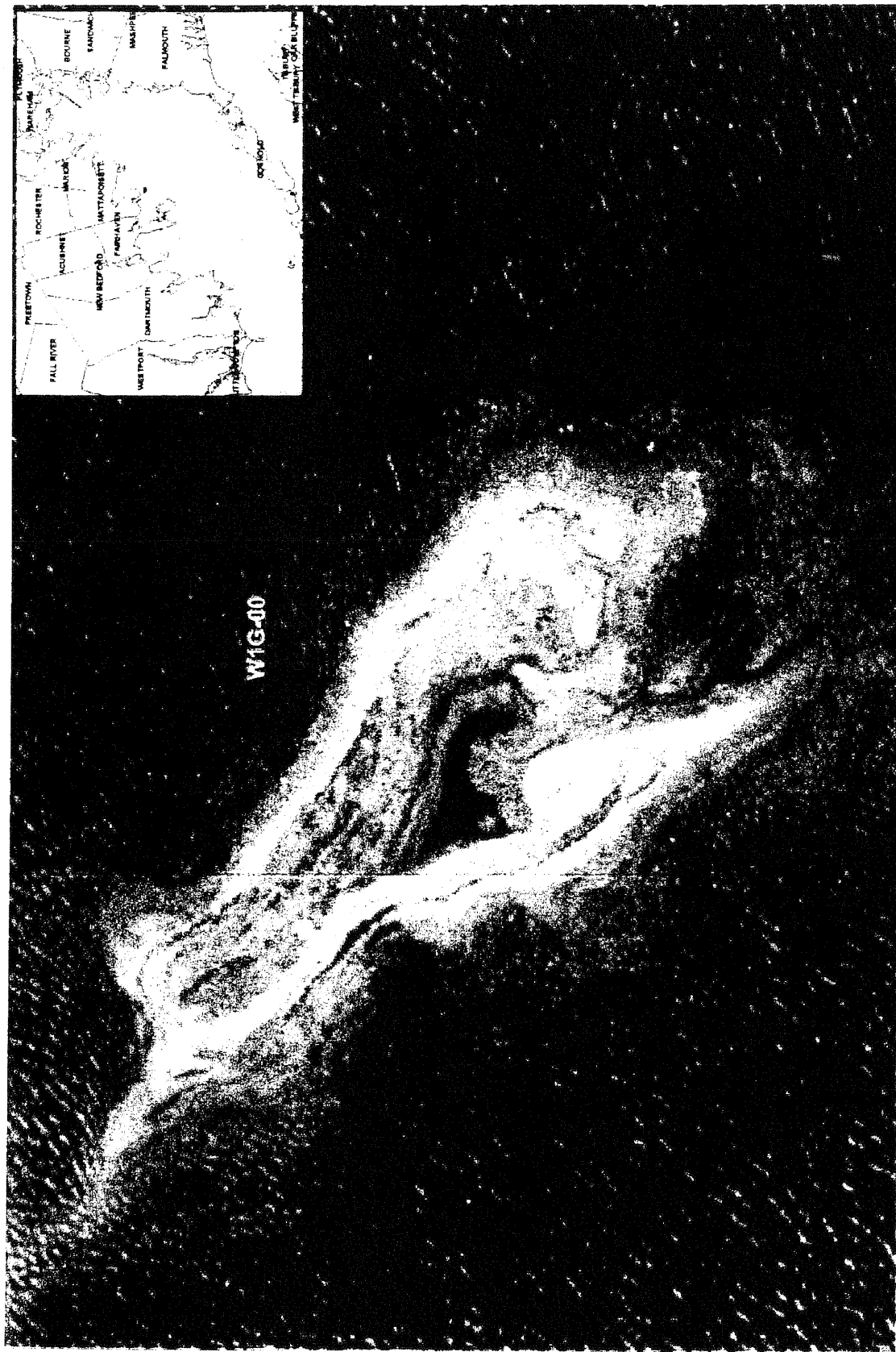

PARTIAL CLASS A-2 RAO SUMMARY

Portions of the Buzzards Bay shoreline were oiled as a result of an April 27, 2003 release of No. 6 fuel oil from Bouchard Barge B120. The shoreline was divided into a total of 149 shoreline segments, 29 of which were found to be unoiled and 120 shoreline segments were found to be oiled to varying degrees. In May 2004, a Partial Class A-2 RAO was submitted for 57 of the 120 segments that comprise the Site.

Characterization activities were conducted to evaluate the extent and magnitude of residual oil impacts, as described in reports including the August 24, 2005 Updated CSM report and the July 27, 2006 Phase II CSA report. As described in the Method 3 Risk Characterization included with the Phase II CSA report, a condition of No Significant Risk has been achieved for human health, public welfare, safety, and the environment at 61 of the remaining 63 shoreline segments, as well as the entire subtidal zone beneath Buzzards Bay. This Partial Class A-2 RAO applies to the 61 of the 63 shoreline segment and the subtidal zone where a condition of No Significant Risk has been achieved. Assessment and/or cleanup activities will be conducted at the two remaining shoreline segments (W1F-02 and W2A-10) that are not included in this RAO, and a separate partial RAO will be submitted for those shoreline segments at the completion of assessment and/or cleanup.
